Hitachi Concludes Absorption-type Company Split Agreement Related to Reorganization of Information and Control Solution Business for Industrial Fields, Security System Business and Printed-circuit Board Manufacturing Business

Tokyo, January 30, 2014 --- Hitachi, Ltd. (TSE: 6501, "Hitachi") on November 25, 2013 announced that it had decided to reorganize and concentrate the information and control solution business for industrial fields, the security system business and the printed-circuit board manufacturing business on April 1, 2014. These businesses are currently spread out across Hitachi and five Group companies. The purpose of the restructuring is to strengthen and expand the infrastructure systems business.

Specifically, Hitachi will transfer and integrate the following businesses into Hitachi Information & Control Solutions, Ltd. ("Hitachi Information & Control Solutions") by way of company split: the security systems development and design business and the printed-circuit board manufacturing business of Hitachi's Infrastructure Systems design and manufacturing business of Hitachi Mito Engineering Co., Ltd. and Mito Engineering Service Co., Ltd.. Furthermore, Hitachi Information & Control Solutions will merge the following two companies. The two companies are Hitachi Advanced Digital, Inc., which is engaged in the embedded systems development and design business, and Ibaraki Hitachi Information Service Co., Ltd., which is engaged in the information and control system development and design business. In an effort to unify management, Hitachi will centralize resources from divisions engaged in the development and design of information and control systems for industrial fields at Hitachi's Infrastructure Systems Company to the new company for which Hitachi Information & Control Solutions will be the successor and the surviving company.

Today, Hitachi concluded an absorption-type company split agreement ("Absorption-type Company Split Agreement") relating to transferring the following businesses into Hitachi Information & Control Solutions by way of a company split ("Company Split"): the security systems development and design business and the printed-circuit board manufacturing business of Hitachi's Infrastructure Systems Company ("Businesses to Be Transferred"). Having signed this agreement, Hitachi has also announced matters that were undecided in the news release issued on November 25, 2013, as follows. Changes to that news release are underlined.

1. Outline of the Company Split

(Note) The company split is deemed to be a simple absorption-type company split, pursuant to Article 784, Paragraph 3 of the Companies Act of Japan. Therefore, Hitachi does not plan to convene a shareholders' meeting to obtain approval for the company split agreement.

(2) Company Spilt Method

This is an absorption-type split in which Hitachi is the transferring company and Hitachi Information & Control Solutions is the successor company.

(3) Details of Allotments Related to the Company Split

Hitachi Information & Control Solutions will allot one share of common stock to Hitachi on April 1, 2014.

(4) Handling of Stock Acquisition Rights and Bonds with Stock Acquisition Rights Accompanying the Company Split

Hitachi has no outstanding stock acquisition rights or bonds with stock acquisition rights.

(5) Capitalization Changes Accompanying the Company Split

The company split will result in no change in capitalization of Hitachi.

(6) Succession of Rights and Obligations

Hitachi Information & Control Solutions will succeed to all rights and obligations, including assets, claims and obligations, contractual status, permits and licenses, and intellectual property of Hitachi as stipulated by the Absorption-type Company Split Agreement.

Moreover, Hitachi Information & Control Solutions will not succeed to the contractual status of Hitachi with respect to the registered employees of Hitachi who are mainly employed in the Business to Be Transferred and the rights and obligations that arise from these contracts in the company split, and these employees shall remain in the employment of Hitachi, and Hitachi shall loan them out to Hitachi Information & Control Solutions, which shall engage these employees in the Business to Be Transferred.

Obligations of Hitachi Information & Control Solutions becoming due after the effective date of the company split are anticipated to be duly performed.

As described in the January 8, 2014 press release titled "Hitachi Announces Changes of Top Management," Hitachi will change its President effective April 1, 2014, in accordance with a resolution passed by a meeting of the Board of Directors held on that day.
