Hitachi Concludes Absorption-type Company Split Agreement Related to the Restructuring of Elevator and Escalator Business in Japan

Tokyo, January 30, 2014 --- Hitachi, Ltd. (TSE: 6501 / "Hitachi") announced on October 23, 2013, that it had decided to transfer its elevator and escalator business in Japan (the "Business to be Transferred") and integrate it in Hitachi Building Systems Co., Ltd. ("Hitachi Building Systems"), a wholly-owned subsidiary, through a company split on April 1, 2014 (the "company split"). The purpose of the restructuring is to strengthen and expand the elevator and escalator business in Japan.

Today, Hitachi concluded an absorption-type company split agreement related to the company split (the "company split agreement"). Having signed this agreement, Hitachi has also announced matters that were undecided in the news release issued on October 23, 2013, as follows. Changes to that news release are underlined.

1. Outline of Company Split

(Note) The company split is deemed to be a simple absorption-type company split, pursuant to Article 784, Paragraph 3, of the Companies Act of Japan. Therefore, Hitachi does not plan to convene a shareholders' meeting to obtain approval for the company split agreement.

(2) Company Split Method

This is an absorption-type split in which Hitachi is the transferring company and Hitachi Building Systems is the successor company.

(3) Details of Allotments Related to the Company Split

Hitachi Building Systems will allot one share of common stock to Hitachi on April 1, 2014.

(4) Handling of Stock Acquisition Rights and Bonds with Stock Acquisition Rights Accompanying the Company Split

Hitachi has no outstanding stock acquisition rights or bonds with stock acquisition rights.

(5) Capitalization Changes Accompanying the Company Split

The company split will result in no change in capitalization of Hitachi.

(6) Succession of Rights and Obligations

Hitachi Building Systems will succeed to all rights and obligations of Hitachi relating only to the business to be transferred, including assets, intellectual property, claims, obligations, contractual status and labor agreements as stipulated in the company split agreement.

(7) Prospect of Fulfillment of Obligations

Obligations of Hitachi Building Systems becoming due after the effective date of the company split are anticipated to be duly performed.

As announced in the news release titled "Hitachi Announces Changes of Top Managements," on January 8, 2014, Hitachi decided at a meeting of the Board of Directors held on that date to change the President effective April 1, 2014.
