Notice Regarding Differences in Previous Forecast and Financial Results for Fiscal 2020

Tokyo, April 28, 2021 --- Hitachi, Ltd. (TSE: 6501, "Hitachi") today announced the financial results for fiscal 2020, the year ended March 31, 2021 (from April1, 2020 to March 31, 2021). Since there is a difference in the forecast announced on February 3, 2021 (the "Previous Forecast") and the financial results for fiscal 2020, Hitachi is providing an overview as follows.

1. Difference in Previous Forecast and Financial Results for Fiscal 2020

(2) Reasons for Difference

The financial results for fiscal 2020 exceeded the Previous Forecast mainly due to revenues increase in IT segment, Smart Life segment, and other segments, in addition to the profit increase through cost reduction. As a result, Hitachi recorded its financial results for fiscal 2020, the year ended March 31, 2021 as above (1).
