

## Hitachi announces decision on year-end dividend

**Tokyo, May 14, 2026** Hitachi, Ltd. (TSE:6501, "Hitachi") today announced that the Board of Directors decided on the year-end dividend for the fiscal year ended March 31, 2026, with March 31, 2026 as the record date, as shown below in view of earnings performance and other factors.
